CERTIFICATE OF INSURANCE: SPONSORS & SPECIALTY

DUE JANUARY 29, 2027

ALL EXHIBITORS, THEIR APPOINTED EXHIBIT CONTRACTORS AND SUPPLIERS MUST SUBMIT A VALID CERTIFICATE OF INSURANCE TO SHOW MANAGEMENT BEFORE DISPLAY SET UP CAN BEGIN.

The following insurance is required:

- ➔ Commercial General Liability, including blanket contractual liability, with limits not less than \$1,000,000 combined for bodily injury & property damage, per occurrence; and \$1,000,000 aggregate.
- ➔ Commercial Automobile Liability insuring owned, non-owned or hired vehicles to be used in and out of the Center, such policy to insure loading or unloading hazards with limits not less than \$500,000 in respect of injuries to any one person in any one occurrence and \$1,000,000 in respect of injuries to more than one person in any occurrence and \$500,000 in respect of damage to property, or \$1,000,000 combined single limit.
- ➔ General Liability and Automobile Liability shall include waiver of subrogation endorsement.
- ➔ Umbrella Liability with limit not less than \$4,000,000. The total combined limit of primary & umbrella/excess liability coverage should not be less than \$5,000,000.
- ➔ Workers Compensation, as required by statute for all work performed in New York State, including Employer Liability with minimum limits of \$1,000,000.
- ➔ Name as Additional Insured: *New York Convention Center Operating Corporation, State of New York, the New York Convention Center Development Corporation, the New York State Urban Development Corporation dba Empire State Development, the Triborough Bridge and Tunnel Authority, the Greater New York Automobile Dealers Association, Inc., and their respective boards of directors, officers, agents, and employees. Insurance carriers shall have no right to subrogation against any additional insured(s).*
- ➔ Additional Insured to receive 30-day notice of cancellation, non-renewal, or material change.
- ➔ All insurance policies shall be Primary & Non-Contributory.
- ➔ All Insurance companies must have a financial rating of "A-VII" or better per the latest edition of Best's Key Rating guide.

Certificate must include the following coverage dates:

Level 3: March 17 - April 7, 2027

Crystal Palace, Level 1, Halls A & B, and North Concourse: March 17 - April 6, 2027

Inner Roadway: March 17 – April 6, 2027

Level 1, Hall C: March 18 – April 6, 2027

Certificate must be submitted by January 29, 2027. Exhibitor WILL NOT be allowed to set up without a valid Certificate of Insurance on file.
